AMENDED
ARTICLES OF INCORPORATION
OF
THE PHILIPPINE SOCIETY OF NEPHROLOGY (PSN), INC.
(Formerly: THE PHILIPPINE SOCIETY OF NEPHROLOGY, INC.)

KNOW ALL MEN BE THESE PRESENTS:

That we, the undersigned, all Filipinos, of legal age, and residents of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a non-stock and non-profit corporation under laws of the Philippines. (as amended on March 22, 2022).

AND WE HEREBY CERTIFY:

FIRST - That the name of the association shall be:

THE PHILIPPINE SOCIETY OF NEPHROLOGY (PSN), INC.

SECOND - That the purposes for which the corporation is being organized are as follows:

1. To advance the knowledge of nephrology and related fields;
2. To promote better understanding of the scientific principles in nephrology among nephrologists in general;
3. To encourage scientific investigation in the field of nephrology;
4. To disseminate the knowledge of nephrology through national and international meetings, local seminars and by other means approved by the members;
5. To promote the highest standards of moral, ethical, compassionate and quality patient care;
6. To initiate and coordinate public health programs aimed at prevention and treatment of renal diseases;
7. To encourage membership in the International Society of Nephrology, the International Pediatric Nephrology Association, and similar regional nephrology associations.

THIRD - That the place where the principal office of the corporation is to be established is at Unit 2406 One San Miguel Condominium, San Miguel Avenue corner Shaw Boulevard, Ortigas, Pasig City. The corporation may however establish branch offices anywhere in the Philippines and abroad as the Board of Trustees may determine. (as amended on April 19, 2012).

1 EIGHTH - That the incorporators are the present members and
2 additional members may be admitted from time to time in
3 accordance with the By-Laws and their names to be
4 submitted to the Securities and Exchange Commission.
